1 SEC. 2. FINDINGS.

- 2 Congress finds the following:
- 3 (1) Iran is the world's leading state sponsor of
- 4 terrorism. It seeks "death to America" and the de-
- 5 struction of the State of Israel.

1	(2) Iran's pursuit of nuclear weapons, its ef-
2	forts to destroy the State of Israel, its support of
3	terrorism, its destabilizing behavior in the Middle
4	East, its development and proliferation of drones
5	and ballistic missiles, and its gross violations of
6	human rights against its own people and the peoples
7	of the Middle East are a threat to the national secu-
8	rity of the United States, our allies, and inter-
9	national peace and security.
10	(3) Iran and its proxies have planned, directed,
11	sponsored, and funded terrorist plots throughout the
12	world and on United States soil, including the Octo-
13	ber 2023, mass murder and hostage-taking of Israeli
14	civilians by Hamas and the killing of at least 31
15	United States citizens in that attack, the 2011 at-
16	tempted assassination of the Saudi Arabian Ambas-
17	sador to the United States in Washington, DC, the
18	1994 bombing of the Asociacion Mutual Israelita Ar-
19	gentina in Buenos Aires, Argentina, which killed
20	over 85 people, and the 2012 bus bombing in
21	Burgas, Bulgaria, which killed 5 Israelis.
22	(4) Experts estimate that Iran as of September
23	2023, has enough highly enriched uranium to
24	produce weapons-grade uranium for 1 nuclear bomb
25	within 12 days and as many as 6 nuclear bombs

	<u> </u>
1	within 1 month. Iran continues to enrich uranium to
2	levels for which there is no conceivable civilian pur-
3	pose and which could only be used to produce a nu-
4	clear weapon.
5	(5) According to multiple United States Direc-
6	tors of National Intelligence, Iran has the largest ar-
7	senal of ballistic missiles in the Middle East. Iran
8	also possesses a robust cruise missile arsenal and
9	advanced drone capability, which threaten United
10	States and allied air and missile defenses. Iran tests,
11	transfers, and even uses these systems in military
12	operations abroad.
13	(6) Iran has given ballistic missiles, drones, and
14	associated technology to the Houthis in Yemen, Shi-
15	ite militias in Iraq, the Assad regime in Syria, and
16	Hezbollah in Lebanon, and is trafficking precision-
17	guided munitions parts through the Middle East to
18	upgrade the rocket forces of its chief proxy,
19	Hezbollah.
20	(7) Iran has sold thousands of drones to Russia
21	for its use in its invasion of Ukraine, leading to
22	mass attacks on civilian infrastructure, and has
23	given Russia the technology and knowledge to

produce these drones in Russia.

1	(8) Iran continues to take United States citi-
2	zens hostage in order to extract ransom payments
3	from the United States and exchange arbitrarily de-
4	tained United States citizens for Iranian agents ar-
5	rested for violating United States sanctions and for
6	other malign activities.
7	(9) The Joint Comprehensive Plan of Action
8	negotiated by former President Barack Obama was
9	fatally flawed, did not eliminate Iran's pathway to a
10	nuclear weapon, and allowed Iran to retain and re-
11	fine its ability to quickly resume its pursuit of a nu-
12	clear weapon.
13	(10) The failed Iran nuclear agreement pro-
14	vided Iran with over \$100,000,000,000 in sanctions
15	relief that was used by Iran to fuel proxy wars
16	across the Middle East.
17	(11) The failed Iran nuclear agreement lifted
18	the United Nations conventional arms embargo on
19	Iran in October 2020, permitting Russia and China
20	to engage in international arms sales with Iran.
21	(12) The failed Iran nuclear agreement also
22	lifted the United Nations missile embargo on Iran in
23	October 2023, allowing Iran to sell and purchase
24	drone and ballistic missile technology.

1	(13) A central flaw of the failed Iran nuclear
2	deal was that the agreement solely focused on nu-
3	clear weapons and did not address non-nuclear
4	issues like Iran's support for terrorism, drone and
5	ballistic missile technology, gross human rights
6	abuses, and Iran's other malign activities.
7	(14) On May 21, 2018, 2 weeks after President
8	Trump withdrew from the failed Iran nuclear deal,
9	former Secretary of State Mike Pompeo laid out 12
10	demands that would need to be met by Iran as part
11	of any agreement related to the lifting of sanctions,
12	and the re-establishment of diplomatic and commer-
13	cial relations with Iran.
14	(15) Former President Donald Trump's max-
15	imum pressure campaign on Iran denied the regime
16	unprecedented revenue it would have otherwise spent
17	on terrorism.
18	(16) On December 31, 2019, then-Iranian
19	President Hassan Rouhani admitted that Iran had
20	lost \$200 billion in revenue because of United States
21	sanctions.
22	(17) Iran's 2019 defense budget cut defense
23	spending by 28 percent, including a 17 percent cut
24	to the Islamic Revolutionary Guard Corps, a des-
25	ignated foreign terrorist organization. Hezbollah ter-

1	rorists and Iranian backed militias were denied re-
2	sources and were forced to cut salaries of their fight-
3	ers.
4	(18) The Iranian rial lost around 70 percent of
5	its value due to President Trump's maximum pres-
6	sure campaign.
7	(19) According to the International Monetary
8	Fund, Iran's accessible foreign exchange reserves
9	plunged to $$4,000,000,000$ in 2020 from
10	\$123,000,000,000 in 2018, or a decrease of over 96
11	percent.
12	(20) During the maximum pressure campaign,
13	the United States was able to achieve the release of
14	2 hostages in Iran, Xiyue Wang and Michael White,
15	without lifting sanctions or transferring cash to
16	Iran.
17	(21) President Joe Biden's relentless attempts
18	to re-enter the failed Iran nuclear agreement squan-
19	dered much of the leverage created by President
20	Trump's maximum pressure campaign.
21	(22) The Biden Administration's pursuit of an
22	even weaker deal with Iran broke previous pledges
23	made by administration officials to pursue a "longer
24	and stronger" deal that extended sunset dates of re-

1	strictions and which would cover a broader range of
2	Iran's malign activity.
3	(23) Amid the multiple failed rounds of talks to
4	get Iran to reenter the Iran nuclear agreement, the
5	Biden administration reportedly offered to remove
6	the Islamic Revolutionary Guard Corps from the
7	Foreign Terrorist Organization list, despite the
8	group's obvious involvement in and support for ter-
9	rorism, until news of this offer became public.
10	(24) The Iranian regime has made more than
11	\$80,000,000,000 in illicit oil sales since President
12	Biden took office due to the administration's lax en-
13	forcement of sanctions on Iranian oil exports. Total
14	Iranian oil exports reached nearly 2,000,000 barrels
15	per day in August 2023, the highest since before the
16	maximum pressure campaign began.
17	(25) In 2021, Iran increased funding for the Is-
18	lamic Revolutionary Guard Corps by 14 percent, re-
19	versing budget cuts imposed as a result of maximum
20	pressure.
21	(26) Iran's accessible foreign exchange reserves
22	have risen from \$4,000,000,000 in 2020 to at least
23	\$43,000,000,000 in 2023.

1	(27) In July 2023, the United States unfroze
2	nearly \$10,000,000,000 held in Iraqi banks for Iraq
3	to pay to the Iranian regime.
4	(28) In August 2023, the Biden Administration
5	agreed to give Iran access to \$6,000,000,000 in pre-
6	viously frozen funds and released several Iranians in
7	prison for violating United States sanctions in ex-
8	change for the release of 5 United States hostages.
9	This represents the largest ransom payment in
10	United States history.
11	(29) On March 18, 2021, in an interview with
12	BBC Persian, President Biden's Special Envoy for
13	Iran and lead United States negotiator in talks to
14	re-enter the Iran deal, Robert Malley, stated "Presi-
15	dent Biden and all of his senior advisers have said
16	this—the maximum pressure campaign has failed. It
17	was a failure, a predicted failure. It hasn't made life
18	any better for the Iranian people; it hasn't made life
19	any better for the United States and the region; it
20	hasn't brought us any closer to this better deal that
21	President Trump spoke about.".
22	(30) In June 2023, it was revealed that the
23	State Department had placed Malley on leave and
24	had suspended his security clearance, reportedly due

1	to accusations that Malley mishandled classified in-
2	formation.
3	(31) In September 2023, it was revealed that
4	Malley had deep ties to several experts who were
5	part of an Iranian government influence operation
6	during the Iran deal negotiations to convince West-
7	ern governments to support lighter demands on
8	Iran. These experts have since served in senior staff
9	positions in the Department of Defense and have ad-
10	vised executive branch officials on issues related to
11	Iran.
12	(32) In September 2022, the Iranian regime's
13	"Morality Police" detained, brutally beat, and killed
14	22-year old Mahsa Amini for allegedly violating Is-
15	lamic dress code. Mahsa's death spurred the largest
16	anti-regime and pro-democracy protests in Iran since
17	the 1979 revolution, with hundreds of thousands of
18	Iranians chanting "Death to the Dictator".
19	(33) Iranian regime forces cracked down on the
20	protests, killing at least 500 protestors, and eventu-
21	ally reinstated street patrols of the Morality Police
22	and has continued brutalizing women who do not ad-
23	here to its strict dress code.
24	(34) On September 12, 2023, the House of
25	Representatives passed the passed the MAHSA Act,

1	which imposes sanctions on Iranian leadership, in-
2	cluding the Supreme Leader of Iran, for their re-
3	sponsibility for Mahsa's death and for their repres-
4	sion of innocent Iranians like Mahsa. The MAHSA
5	Act represents a Congress bipartisan consensus that
6	the Biden administration's policy on Iran has clearly
7	failed and that Iranian regime officials must be held
8	accountable for their crimes.
9	(35) Iranian proxy group Hamas carried out a
10	massacre of Israeli and other civilians on October 7,
11	2023, that killed more than 1,400 Israelis and for-
10	eign nationals, including United States citizens, and
12	, ,

12	SEC. 4. STATEMENT OF POLICY.
13	It is the policy of the United States as follows:
14	(1) To deny Iran all paths to a nuclear weapon
15	and intercontinental ballistic missiles capability, in-
16	cluding by permanently, verifiably, and irreversibly
17	eliminating its capabilities related to enrichment.
18	(2) To deter and defeat any attempts by Iran
19	and its terrorist proxies to destroy the State of
20	Israel.
21	(3) To roll back the totality of Iran's malign in-
22	fluence and activities in the Middle East.
23	(4) To support the human rights of the people
24	of Iran and to encourage their continued opposition
25	to their illegitimate and brutal regime.

1	(5) To require that any new agreement with
2	Iran should be submitted to the Senate for ratifica-
3	tion as a treaty.
4	(6) To impose maximum economic pressure on
5	Iran, and keep all sanctions in place on Iran, until
6	the regime fulfills the following 12 demands laid out
7	by former Secretary of State Pompeo on May 21,
8	2018:
9	(A) Iran must declare to the International
10	Atomic Energy Agency a full account of the
11	prior military dimensions of its nuclear pro-
12	gram, and permanently and verifiably abandon
13	such work in perpetuity.
14	(B) Iran must stop enrichment and never
15	pursue plutonium reprocessing, including clos-
16	ing its heavy water reactor.
17	(C) Iran must also provide the Inter-
18	national Atomic Energy Agency with unquali-
19	fied access to all sites throughout the entire
20	country.
21	(D) Iran must end its proliferation of bal-
22	listic missiles and halt further launching or de-
23	velopment of nuclear-capable missile systems.
24	(E) Iran must release all United States
25	citizens as well as citizens of United States

1	partners and allies, each of them detained on
2	spurious charges.
3	(F) Iran must end its support for ter-
4	rorism, including Hezbollah, Hamas and Pales-
5	tinian Islamic Jihad.
6	(G) Iran must respect the sovereignty of
7	the Iraqi Government and permit the dis-
8	arming, demobilization and reintegration of Ira-
9	nian backed militias.
10	(H) Iran must end its military support for
11	the Houthi terrorists and work towards a
12	peaceful, political settlement in Yemen.
13	(I) Iran must withdraw all forces under
14	Iranian command throughout the entirety of
15	Syria.
16	(J) Iran must end support for the Taliban
17	and other terrorists in Afghanistan and the re-
18	gion and cease harboring senior al-Qaeda lead-
19	ers.
20	(K) Iran must end the Islamic Revolu-
21	tionary Guard Corps' support for terrorists
22	around the world.
23	(L) Iran must end its threatening behavior
24	against its neighbors including its threats to de-
25	stroy Israel and its firing of missiles at Saudi

1	Arabia and the United Arab Emirates, and
2	threats to international shipping and destruc-
3	tive cyberattacks.
4	SEC. 5. SEVERABILITY.
5	If any provision of this Act, or an amendment made
6	by this Act, or the application of such provision or amend-
7	ment to any person or circumstance, is held to be invalid,
8	the remainder of this Act, the amendments made by this
9	Act, and the application of such provision and amend-
10	ments to other persons or circumstances, shall not be af-
11	fected.

1	(b) Prohibition on Removal of Persons From
2	SDN List.—The President may not remove the following
3	individuals or entities from the Specially Designated Na-
4	tionals and Blocked Persons list maintained by the Office
5	of Foreign Asset Control of the Department of the Treas-
6	ury, if such persons were placed on such list during the
7	period beginning on May 8, 2019, and ending January 20,
8	2021, unless the President submits a certification to Con-
9	gress pursuant to section 8 of the Iran Sanctions Act of
10	1996 (50 U.S.C. 1701 note) as amended by this Act:
11	(1) Any Iranian individual or entity.
12	(2) Any individual or entity included in such
13	list as a result of activities connected to Iran.
14	(3) Asa'iab ahl al-Haq, Zainabiyoun,
15	Fatemiyoun, and Harakat Hezbollah al-Nujaba.
16	(c) Reimposition of Sanctions.—Any sanctions
17	imposed during the period beginning on May 8, 2019, and
18	ending January 20, 2021, with respect to any person de-
19	scribed in subsection $(b)(1)$ or $(b)(2)$, and subsequently
20	lifted before the date of the enactment of this Act, shall
21	be reimposed with respect to such persons beginning on
22	the date of the enactment of this Act and shall remain
23	in effect until the date on which the President submits
24	a certification to Congress pursuant to section 8 of the

1	Iran Sanctions Act of 1996 (50 U.S.C. 1701 note) as
2	amended by this Act.
3	SEC. 102. SANCTIONS WITH RESPECT TO THE SUPREME
4	LEADER OF IRAN.
5	(a) In General.—Not later than 30 days after the
6	date of the enactment of this Act, the President shall im-
7	pose the sanctions described in subsection (b) with respect
8	to the following individuals:
9	(1) The Supreme Leader of the Islamic Repub-
10	lie of Iran.
11	(2) Each member of the Iranian Supreme
12	Leader's Office.
13	(3) Any person appointed by the Supreme
14	Leader of Iran or the Supreme Leader's Office to a
15	position as—
16	(A) a state official of Iran;
17	(B) as the head of an entity located in
18	Iran; or
19	(C) as the head of an entity located outside
20	of Iran that is owned or controlled by one or
21	more entities in Iran.
22	(4) Any person appointed to a position de-
23	scribed in subparagraphs (A) through (C) of para-
24	graph (3) by a person described in paragraph (3).

1	(5) Any person the President determines has
2	materially assisted, sponsored, or provided financial,
3	material, or technological support for, or goods or
4	services to or in support of any person whose prop-
5	erty and interests in property are blocked pursuant
6	to this section.
7	(6) Any person the President determines is
8	owned or controlled by, or to have acted or pur-
9	ported to act for or on behalf of, directly or indi-
10	rectly, any person whose property and interests in

- 16 SEC. 303. MEASURES WITH RESPECT TO ANSARALLAH IN
- 17 YEMEN.
- 18 (a) Sense of Congress.—It is the sense of the Con-
- 19 gress that the designation of the Ansarallah in Yemen
- 20 (otherwise known as the "Houthis") as a foreign terrorist
- 21 organization by former Secretary of State Mike Pompeo,
- 22 which took effect on January 19, 2021, was an essential
- 23 step to hold Iran's proxies accountable.
- 24 (b) FINDINGS.—Congress finds the following:

1	(1) The Houthis are armed, trained, and ad-
2	vised by the Islamic Revolutionary Guard Corps, an
3	entity designated as a foreign terrorist organization
4	pursuant to section 219 of the Immigration and Na-
5	tionality Act (8 U.S.C. 1189).
6	(2) According to former Secretary of State
7	Mike Pompeo, the Houthis are responsible for a
8	number of terrorist acts, "including cross-border at-
9	tacks threatening civilian populations, infrastruc-
10	ture, and commercial shipping.".
11	(c) Designation Required.—Not later than 10
12	days after the date of the enactment of this Act, the Sec-
13	retary of State shall designate Ansarallah, otherwise
14	known as "Houthis", as a foreign terrorist organization
15	under section 219 of the Immigration and Nationality Act
16	(8 U.S.C. 1189).
17	(d) LISTING REQUIRED.—Not later than 10 days
18	after the date of the enactment of this Act, the Secretary
19	of the Treasury shall place Ansarallah, otherwise known
20	as "Houthis," on the list of Specially Designated Nation-
21	als and Blocked Persons maintained by the Office of For-
22	eign Asset Control of the Department of the Treasury.
23	(e) REVIVAL OF FORMER WAIVERS.—Beginning on
24	the date that is 10 days after the date of the enactment
25	of this Act, all licenses and waivers issued in relation to

1	the designation of Ansarallah as a Foreign Terrorist Orga-
2	nization or its placement on the list of Specially Des-
3	ignated Nationals and Blocked Persons that were in effect
4	as of January 20, 2021, shall return to force and remain

22	eign person that is an official, agent, affiliate of, or owned
23	or controlled by Kata'ib Sayyid al-Shuhada, Kata'ib al-
24	Imam Ali, Saraya Khorasani, or the Badr Corps, meets
25	the criteria for—
